A. CBOC Member Updates

A new student representative for CBOC was approved at the April 9, 2024 Board of Trustees meeting. Sajiv Jampani is the GECA Liaison Officer with the Associated Students of Gavilan College (ASGC).

B. President's Update

Dr. Avila provided the committee with the following updates:

Began by recognizing college staff and college campus. Recognizing Trustee Rachel Perez who was recognized by Speaker Robert Rivas (D-Salinas) and the California State Assembly as Woman of the Year for the 29th Assembly District. Recognizes staff member Victor De Reza who works with our ESL Non-Credit Program for receiving the Caesar Chavez Community Champion Award in Education by C.A.R.A.S. ESL Program at Gavilan College has already exceeded the enrollment numbers of pre-Covid.

Dr. Avila attended the annual suppositum of presidents for community colleges, where Gavilan was recognized as best practice for diversity in hiring. Dr. Avila was also invited to present at the Board of Governors in Sacramento in regards to Gavilan's diversity and hiring processes. The Board of Governors, similar to our Board of Trustees, for all community colleges but are appointed by the governor.

Dr. Avila also attended the California Community College Athletic Commission Convention where they inducted Susan Dodd. Two Gavilan staff are now inducted into the Hall of Fame.

Week of April 8, 2024, kicked off the International Poppy Jasper Festival on campus.

C. Quarterly Bond Expenditures

Katie Brewer (Program Manager, Volz Company) reviewed the fiscal year 2023-2024, Q2 Whole Program Report, Project Summary Report and the Sub-Project Detail Report with the committee. These reports are from inception of the bond through December 31, 2023.

Expenditures during the second quarter of 2023/24 were \$9,785,908 bringing the overall expenditures to \$54,331,108.

Highlights for the first quarter include:

- SBCC, LSRC and Site Improvement projects has the most spending during Q2
- SBCC started construction in July 2023 and around \$16M has been spent
- Continuation of design work for LSRC and other site improvement projects during the second quarter

• Covered Walkways Replacement project was completed in December 2023
